



**INVITATION TO BID FOR PROCUREMENT OF GOODS:

- The *National Children's Hospital (NCH)*, through the *DOH Sub-Allotment Advice No. 2022-02-0454 dated February 10, 2022*, intends to apply the sum of *One Hundred Fifty Thousand Pesos (Php 150,000.00)* being the ABC to payments under the contract for each item/equipment. Bids received in excess of the ABC per item/equipment shall be automatically rejected at bid opening.

- The *NCH* now invites bids for the above Procurement Projects. Delivery of goods/equipment is required within one hundred twenty (120) calendar days from issuance of a Purchase Order/Contract or any date determined by the PE. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from *NCH-BAC Secretariat* and inspect the Bidding Documents at the address given below during **8:00 A.M. to 5:00 P.M., Monday to Friday**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **May 20, 2022 up to June 17, 2022** from the given address and website of the Philippine Government Procurement Electronic Procurement System (PhilGEPS) and the website of NCH and upon

payment of the applicable fee for the Bidding Documents, pursuant to the -latest Guidelines issued by the GPPB, in the amount stated above.

The *NCH* will hold a Pre-Bid Conference on **May 31, 2022/Tuesday, 9:00A.M.** at **6<sup>th</sup> Floor Multi-Purpose Hall, Medical Arts Building, NCH** and/or through video conferencing or webcasting **via NCH-BAC official Facebook page—i.e., National Children’s Hospital – Bids and Awards Committee**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **June 17, 2022/Friday, 9:00A.M.** at **6<sup>th</sup> Floor Multi-Purpose Hall, Medical Arts Building, NCH**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **June 17, 2022/Friday, 9:00A.M** at **6<sup>th</sup> Floor Multi-Purpose Hall, Medical Arts Building, NCH**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

The *NCH* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
